

Registration Agreement Neuro4D Conference 2025

Scope of Agreement

The working language of the Event is English.

This agreement constitutes the entire agreement between bioExpert ('bE') and the delegate ('Delegate') regarding registration and participation in the Neuro4D Conference to be held in Mainz, Germany May 18 to 20, 2024 (hereinafter the 'Event').

bE reserves the right to adapt the program and content of presentations, poster sessions and panel discussions. Should the Event be cancelled or the location be changed for reasons or circumstances beyond our control, we reserve the right to reschedule the Event, including changing the location, upon written notice to you. Should the event fail to be rescheduled for any reason, Delegate will be refunded 70% of all moneys received by bioExpert from Delegate for the Event.

Event participation is personal; however, you may request a change of Delegate prior to the start of the Event (latest May 12, 2025). Nonappearance of Delegate will not affect your obligation to pay the conference fee. No persons other than those officially registered may attend any part of the Event.

Delegate warrants and represents that his conduct or any information provided and presented will not contain anything that is defamatory, obscene, false or misleading, or otherwise violate any intellectual property rights, or rights of any person, and will not violate any applicable law or regulation.

Delegates are responsible for their own insurance (including, but not limited to, travel insurance, personal effects and personal insurance), and visas. Delegates are responsible for their own travel arrangements.

Price before March 15, 2025, MEZ: 1590 €, plus tax.

Price after March 15, 2025, MEZ: 1990 €, plus tax.

It includes participation for the entire Event, arranged meals and drinks, the conference dinner, and the accommodation from Sunday May 18 to Tuesday May 20, 2025 in the conference hotel. Please clear your rooms on Tuesday May 20 before 11 am and leave your luggage at the registration desk of the hotel.

Price before March 15, 2024, MEZ: 790 €, plus tax.

After March 15, 2024, MEZ: 990 €, plus tax.

The total fees specified here above are subject to 19% German VAT, which shall be payable in addition. This is required, as the event is taking place on German soil. All Delegates are required to submit full payment of the conference fee and VAT within 10 days of the date of the invoice. Registration will not be issued until the full amount has been received.
